8. Deputy Director (Admin.), AIIMS Mangalagiri..... Member Secretary

The Chairman, PRC shall be empowered to invite/co-opt resource persons/ specialists to enable effective review and monitoring of the AIIMS, Mangalagiri project. The PRC shall monitor and review the approved project and keep the Ministry informed of all its decisions. All minutes of meeting shall be circulated to Ministry and put up before the GB.
